

Southampton Yoga Association Privacy Statement

Your privacy is important to us and we want you to know what we do with your data when you use our site or communicate with us.

1. Introduction -

Southampton Yoga Association respects your right to privacy. The purpose of this website Privacy Statement is to outline how we deal with any personal data you provide to us. By visiting southamptonyoga.org.uk, you are accepting the terms of this Privacy Statement. Any external links to other websites are clearly identifiable as such, and we are not responsible for the content or the privacy policies of these other websites.

2. Types of Information Collected -

Personal Data This is data that identifies you or can be used to identify or contact you and may include your name, company name, address, email address, and telephone number. Such information is only collected from you if you voluntarily submit it to us.

3. Purposes for which we hold your information –

Personal Data. We will process any Personal Data you provide to us for the following purposes:(i) to provide you with the information or services you have requested;(ii) to contact you if required in connection with your request or to respond to any communications you might send to us;(iii) to send you the Southampton Yoga Association newsletter, event alerts, information about product releases, service notifications and to communicate with you about relevant information and activities.

4. Disclosure of Information to Third Parties - We do not sell, trade or rent your personal information to others. All information is used solely for our own internal marketing. We will disclose your personal data if we believe in good faith that we are required to disclose it in order to comply with any applicable law, a summons, a search warrant, a court or regulatory order, or other statutory requirement.

5. Users under 18 – southamptonyoga.org.uk content is not directed at users under 18 years of age. When you provide information about yourself as a user, you are thus representing yourself as 18 years of age or older. Our policy is that we do not knowingly collect, use, or disclose personal information about visitors under 18 years of age. However if we do become aware of having collected personally identifiable information from a user under 18 without consent of a parent or legal guardian, we will remove such information from our servers.

6. Security - Your personal data is held by Southampton Yoga Association in accordance with industry best practices. We do not store your credit card information, number, expiry date or CVV security code. We use an online booking system called Bookwhen and their privacy policy can be accessed here <https://bookwhen.com/privacy>.

7. Updating, Verifying and Deleting Personal Data - You have a right to have your personal data corrected, if inaccurate, or, in certain circumstances, erased. Please forward any such requests in writing by email to membership@southamptonyoga.org.uk. We contact everyone on our mailing list once a year, and ask them if they want their personal details removed from our database

8. Right of Access to Your Personal Data - To find out what personal data we hold on you or to have your personal data updated, amended or removed from our database, please email us at membership@southamptonyoga.org.uk

Changes to the Privacy Statement - Any changes to this Privacy Statement will be posted on this website so you are always aware of what information we collect, how we use it, and under what circumstances, if any, we disclose it. If at any time we decide to use personal data in a manner significantly different from that stated in this Privacy Statement, or otherwise disclosed to you at the time it was collected, we will notify you by email, and you will have a choice as to whether or not we use your information in the new manner.

10. Governing Law and Jurisdiction - This Privacy Statement is governed by the laws of the UK, and is subject to the exclusive jurisdiction of the British courts.
